Race will take place on July 18, 2009 at 8:00am.

**EVENT SCHEDULE:** Race and walk will start at 8:00 a.m. SHARP in front of the Gypsum Town Hall. **COURSE:** 5K loop course.

**PARKING:** Please park at the Gypsum Sports Complex, 3295 Cooley Mesa Rd. Take the stairs at the WEST end of the parking lot down to the race starting area located at the entrance to the Town Hall Park.

**AWARDS:** The awards ceremony starts @ 9:15 a.m. in front of the Town Hall. Awards will be presented to 1st, 2nd and 3rd place overall male and female. Ribbons will be presented to 1st, 2nd and 3rd place finishers in each category. Categories: 13 and under; 14 – 19; 20 – 29; 30 – 39; 40 – 49; 50 – 59; 60 – 69; 70+. There will be one walker's category. All entrants receive commemorative hats. Gypsum Daze Parade will follow the event at 11:00am.
